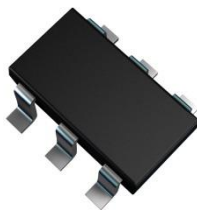

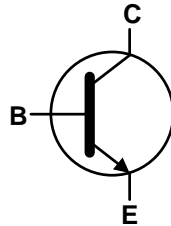

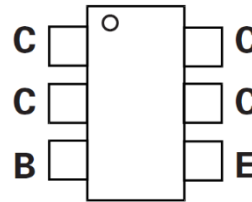

Pin-Out

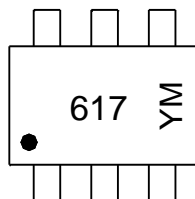

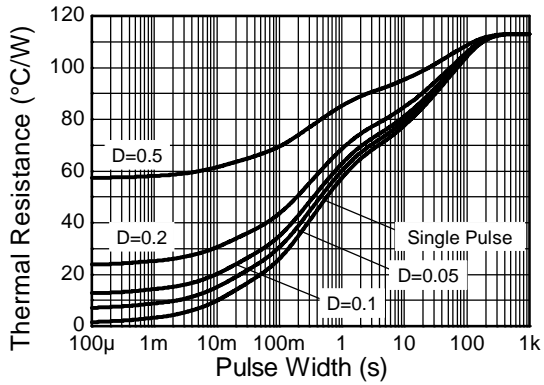

Derating Curve



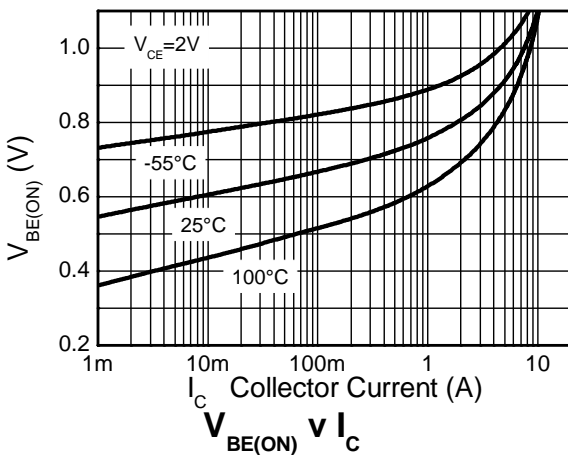
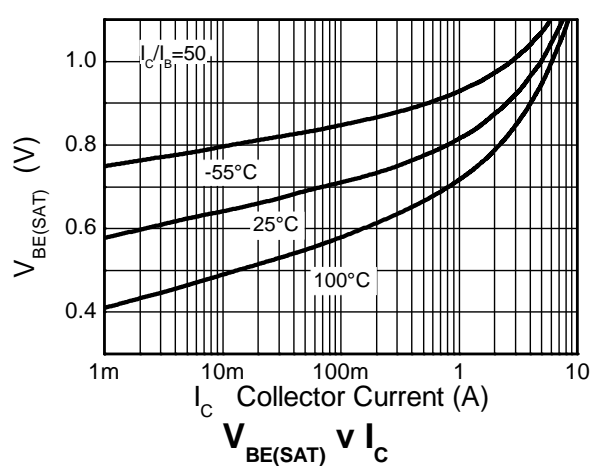
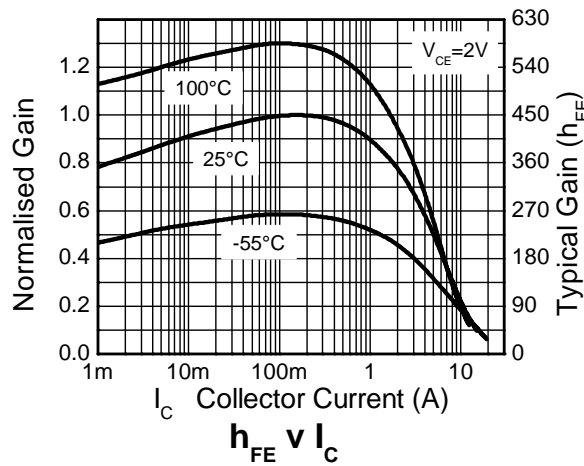
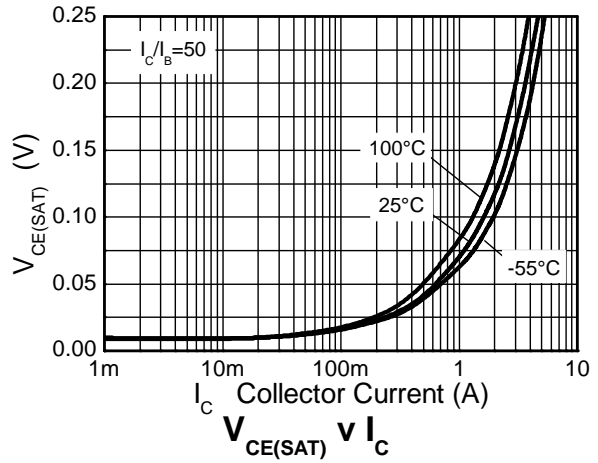
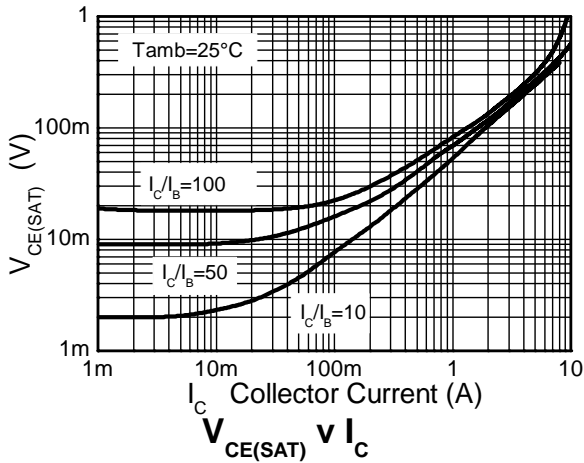

Package Outline Dimensions

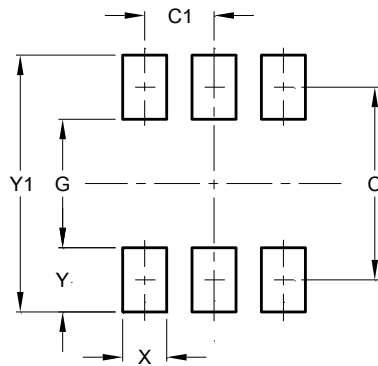
