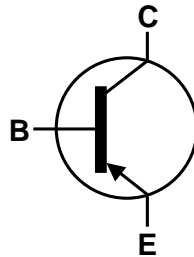

Description

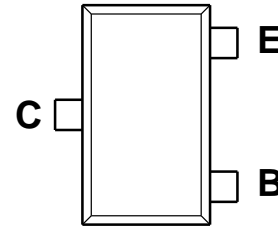

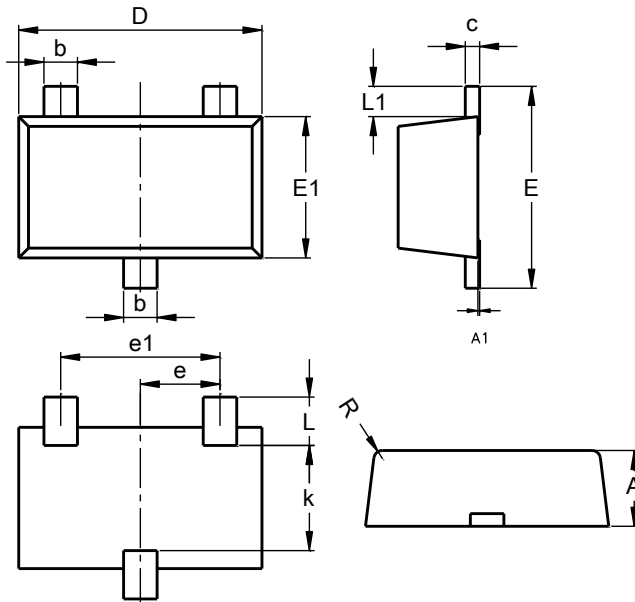
